



# 27th ART FAIR at the Frauenmuseum (Women's Museum) Bonn 11. - 13.11.2022

### **OPEN CALL**

The **Frauenmuseum** in Bonn is hosting its **27th ART FAIR** and offers 80 international female artists a special platform to personally present and sell their work to a wide audience in its exhibition rooms. The "Young Art Forum" was successfully introduced as a new part of our established Art Fair last year. Our goal is to show our visitors the broad spectrum of developments in contemporary art and to present young as well as established female artists to the public.

On Saturday morning (9:30-12:00) a small event for participating artists will take place (in German).

#### **EXHIBITION SPACE**

The Art Fair will take place in the exhibition rooms of the Frauenmuseum, which cover an area of over 2.000 sqm on 3 floors. Due to the museum's architecture stand areas differ; there are no boxes. Each artist will be allocated a stand area of approx. 9 sqm with one wall, which will be decided by the Curator team.

The **stand fee** is € **450** for established artists (ground floor and 1st floor), and reduced to € **300** for "Young Art Forum" participants, 35 years and younger (2nd floor).

#### APPLICATION

Applications are open to professional female artists aged 18 and over from any country and from all areas of the fine arts. A Jury chaired by Marianne Pitzen, Director of the Women's Museum, decides on admission following evaluation of all compliant applications.

#### VALENTINE ROTHE AND RENATE HENDRICKS AWARD

The Valentine Rothe and Renate Hendricks Award for Young Women Artists will be awarded again this year. All participating artists of the 27th Art Fair who are 35 years (born in 1987) or younger will be considered.

#### AUDIENCE AWARD

Each visitor to the Art Fair has the opportunity to vote for the artist whose work impressed the most. The winner will be awarded € 500.

# By applying, I agree to be bound by the provisions of the invitation and, if selected, by the following conditions of participation:

- 1. All selected artists are required to be present during the Art Fair personally on all days.
- 2. Each artist is assigned a stand space of approx. 9sqm. The stand fee is € 450 resp. € 300 (includes the costs for the catalogue, flyer, public relations, house expenses as well as for an event for the participating artists). Payment of fee is due on the date stated in the contract.
- 3. Each artist provides at her own expense and is responsible for her own set-up, technical equipment and transport.
- 4. The artist consents to the publication of image/photo/film and information material free of charge on the internet, in publications or in the media for press and communication work.
- 5. The Women's Museum does not provide insurance cover and assumes no liability for the artworks.
- 6. The Women's Museum is entitled to postpone the Art Fair if a valid reason for which it is not responsible makes this necessary (force majeure). All official Covid-regulations in force at the time of the Art Fair will be complied with.

The Jury will decide on admission to the Art Fair by the end of May 2022 and will inform of its decision in writing. The decision of the Jury is final.
